#### **Farewell and welcome**

Last month, we farewelled Executive Director Melissa Gill who will be on paternal leave until returning to the Ministry of Social Development in her new role as Deputy Chief Executive of the Organisational Assurance and Communication Group. We thank Melissa for her leadership over the past nine months and her commitment to making a real difference to the lives of tamariki and rangatahi.

Next week, we welcome Arran Jones as our new Executive Director. Arran has held a number of leadership roles at the Ministry of Social Development, including with Legal Services, the Office of the Chief Executive and Work and Income. He also helped establish Oranga Tamariki, having led a workstream within the Investing in Children programme, and returns to the Ministry of Social Development having been the Head of Privacy at ACC.

Our Chief Monitor Nova Banaghan has been Acting Executive Director.

# **Regional hui**

These past few months have been busy, with 19 regional hui held around the country, providing participants a greater understanding of how the Independent Children's Monitor, Office of the Children's Commissioner and the Office of the Ombudsman are working to strengthen independent oversight of the Oranga Tamariki System.

Thank you to everyone who took the time to come along to listen and contribute to these discussions. We hope you found the hui helpful; it has been invaluable for us to meet and connect with you.

In total, 525 participants attended the hui, with 190 completing a feedback form and 144 of those expressing interest in being involved in future workshops. Many noted how good it was to see all three oversight agencies together and to understand what each organisation's role and function is. They also commented on how helpful it was to further understand the Ombudsman's Office's role and function, including the complaints process, understanding what barriers exist and being able to provide people with a voice. For us, it was helpful to receive feedback on how we could improve future hui, including better timekeeping, more time for discussions, and more opportunities for networking and providing feedback.

We will take onboard all the feedback we received in shaping our future mahi.

## **Recruitment – on hold**

In December 2019, Cabinet made further decisions to support the development of the Oversight of the Oranga Tamariki System and Children's Commission Legislation Bill.
